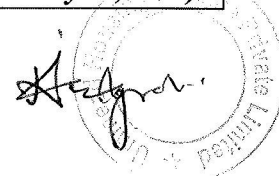

However, due to certain taxation issues u/s 194LC of Income Tax Act, the Company with the consent of the Majority Debenture Holders, has decided to redeem the NCDs **(Part Redemption)** as per scheduled repayment dates as intimated earlier vide letter dated May 17, 2022. Therefore, by this second amendment, the Company is reinstating the intimation of record date dated May 17, 2022.

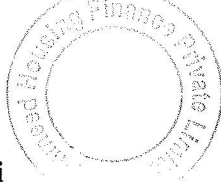

